The 200 Club is a members only lottery for up to 200 individuals, with a monthly and annual lottery prize draw. The aim of the club is to raise funds to support the charity, Crossroads Care Ribble Valley in their work of caring for the carer and the person they are caring for. The services provided include respite care, personal care and emotional support for carers.

Crossroads Care Ribble Valley is an organisation people turn to when they know they are struggling and need help, but don't know what that support looks like or how they can access it.

Through the funds raised by the 200 Club, Crossroads Care are able to provide free and confidential information to support carers and the people they care for. When possible, the funds may also help to cover the shortfall in funding respite care provision.

Rules

1. The purpose of the lottery is to raise money to support the operations of Crossroads Care Ribble Valley, which is suffering a severe shortfall in funding its respite care provision.
2. The 200 Club will be run by an Administrative Committee, comprising the Promoter, an Administrator, Administrators assistant / deputy, along with the members of the Fund Raising committee of Crossroads Care Ribble Valley. In the event of a dispute the decision of this committee will be final.
3. The target membership is to be 200 - only numbers sold will be entered in the draws.
4. Membership shares will be sold at £5.00 per month for a minimum contracted period of twelve months payable by standing order, or £60 cash twelve months in advance.
5. Each member will be allocated a unique number between 1 to 200 and this number cannot be changed within competition. This number will only be valid for the period paid for.
6. Money paid for shares will be non-refundable should a member wish to discontinue membership.
7. A monthly prize will be dependant on the number of subscribing members, but it is proposed that this will be 15 - 20% of the total amount invested, after running expenses of the club, These expenses will not exceed 10% in any twelve-month period. If 200 members are recruited this will produce a net income of approximately £700 per month.
8. Draws to be held on the following basis - pro rata to the final number of Club Members.
 - a. If the club has 70 members but less 100 at the start of the competition there will be:
 - 12 Monthly draws of £40 - £20 - £10
 - 1 Annual draw of £200
 - B. if the club has 100 members up to the limit of 200 at the start of the competition there will be:
 - 12 Monthly draws of £60 - £40 - £20
 - 1 Annual draw of £500
9. The monthly draw will take place on the first Monday of each month.
10. The winner of each draw be notified by either email or post and the results will appear on the Crossroads Care Ribble Valley website.
(www.crossroadscaribblevalley.co.uk) Winning cheques will be posted within three days of the draw taking place.
11. After payment of prize money and expenses the balance will be transferred to Crossroads Care Ribble Valley on a quarterly basis.
12. The competition is registered under the Small Gaming and Lotteries legislation.
